Road Closure

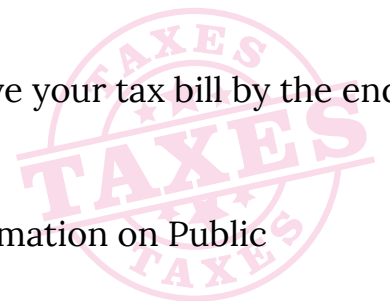

Sewer Plant Project:

The Village has been working on planning a new sewer plant for a few years now. Fourth Coast/St. Lawrence Engineering is designing this project for us and our plans have to be submitted to EFC by May 1st, 2023. The Village Board is hiring WCP Consultants for Grant and Municipal Consulting Services to assist with the cost of the project.

Noble Street Bridge Project:

Jefferson County is planning on starting the underground utility work for this project, this year. Also, the lift station would need to be moved due to the design of the new bridge. The Noble Street bridge project is being handled and funded by Jefferson County and New York State. Due to the issues with the manufacturing/supply of the lift station, this project has been delayed.



RECYCLING PICKUP

Recycling is picked up on Wednesdays, all containers must be by the curb at 8 AM. Recycling is free for Village Residents but all recyclables **MUST** be separated. **DO NOT BRING IN RECYCLING FROM OUTSIDE THE VILLAGE LIMITS.**

IF YOUR RECYCLING WAS NOT PICKED UP, THERE SHOULD BE A BRIGHT **ORANGE** REJECTION STICKER ON IT.



TRASH PICKUP

Trash is picked up on Thursdays, all bags must be to the curb by 8 AM or Village Public Works will not pick up your bags. **ALL BAGS MUST HAVE A STICKER.** Stickers can be purchased in the Village Office or Online. If you purchase stickers online, they will be mailed to the address provided. All online purchases have a 3% FEE. It has been taking 3-4 days for residents to receive them in the mail so please order ahead, we can not control mailing delays.
